Sir/ Madam,

I am directed to inform you that, the Western Odisha Development Council in its 49<sup>th</sup> and 50<sup>th</sup> meeting of the Council has unanimously resolved to get, the sanctioned projects in favour of Educational Institutions such as School, College etc. & other Institutions such as Club, Library Building, Pathagara etc., executed by their respective Management Committees/ Development Committees. All the Educational Institutions such as School, College etc. have their own Management Committees/ development Committees constituted under established Rules. Accordingly it was decided in the Council Meeting to get the WODC projects executed by the concerned Management Committees/ Development Committees for quick and quality execution of the projects as well as for the greater interest of the public.

To make it more clear, the Council further in its 53<sup>rd</sup> meeting held on 27.1.2018 decided that, even if estimated cost of such project is more than 5 lakh, no tender procedure will be followed by the Executing Agency because the project sanctioned in favour of Educational Institution, and other institutions like Pathagara and Clubs etc. are of simple technical in nature. That's why it has been decided to execute the projects by the Committee under close technical supervision of the concerned Executing Agency. Further, it was decided by the Council not to include any charges such as Pro rata Charges, Over head charges, contractor's profit etc. in the estimate of such projects.

The above decisions of the WODC may kindly be followed scrupulously.


