**PROCEEDING OF THE 62<sup>nd</sup> MEETING OF THE WODC HELD ON 23.08.2023  
AT 12 NOON UNDER THE CHAIRMANSHIP OF SRI ASIT TRIPATHY, HON'BLE  
CHAIRMAN, WODC AT 6<sup>TH</sup> FLOOR, RAJIV BHAWAN, BHUBANESWAR**

The 62<sup>nd</sup> meeting of the Western Odisha Development Council (WODC) was held on **23.08.2023 at 12 Noon** under the Chairmanship of Sri Asit Tripathy, Hon'ble Chairman, WODC in the conference hall of WODC, 6<sup>th</sup> Floor, Rajiv Bhawan, Bhubaneswar. The list of Members present in the meeting is placed at **Annexure-I**.

At the outset, Hon'ble Chairman welcomed all Members of the Council as well as the RDC (ND), Sambalpur, RDC(ND), Berhampur, Adviser to WODC and Chief Executive Officer-cum-Member Secretary, WODC. Initiating the discussion, Hon'ble Chairman expressed his gratitude to the Hon'ble Chief Minister, Odisha for enhancement of GIA of WODC. He also opined that, when he took over the charge of WODC, his important mandate was to monitor different developmental projects in Western Odisha for its timely completion. He further emphasized on completion of incomplete projects on priority basis and stated that, an amount of Rs.62.07 crores has already been sanctioned and placed with the Collectors for completion of 741 numbers of incomplete Community Centre, Kalyan Mandap and Mandaps under MMSG initiative.

During discussion, Hon'ble MLA, Bargarh, Khariar and Lanjigarh, Adviser to WODC and other Expert Members expressed their thankfulness to the Hon'ble Chief Minister for enhancement of the GIA of WODC and consideration of eye-catching proposals in different sectors such as Auditorium, Town Halls, Eco Tourism infrastructure, Sports infrastructure, Multipurpose Halls for Govt./ Aided Colleges of Council area, infrastructure development in livelihood sector and particularly Mukhya Mantri Sabha Ghar initiative. They appreciated the efforts of Hon'ble Chairman for the measures taken for transparency in the selection of the viable and public oriented projects which helps WODC branding. Hon'ble MLA, Bargarh, Khariar and Lanjigarh emphasized on sanction of funds towards development of cultural activities, tourism sector and infrastructural development of sports activities in their respective districts. They emphatically expressed that WODC is now in correct path to meet its objectives for which it was established.

RDC (SD), Berhampur opined that, the districts should suggest feasible and felt need big projects for sanction of funds under WODC Grant. Similarly, the RDC (ND), Sambalpur opined that WODC has become vibrant by the present Hon'ble Chairman for making the District Collectors actively involved in WODC funded projects. Regular review at the WODC level and at the level of the Collectors as well every month has substantially improved the execution of the projects as well as submission of feasibility reports.

**1. Confirmation of the proceedings of the 61<sup>st</sup> Council Meeting Dt.10.04.2023.**

The Council after threadbare discussion confirmed the proceedings of the 61<sup>st</sup> meeting of the Council.

**2. Approval of expenditure incurred by WODC during the financial year :2023-24 (01.04.2023 to 20.08.2023)**

The Council approved the expenditure amounting to **Rs.103,32,75,986/-** (Rupees one hundred three crore thirty two lakh seventy five thousand nine hundred eighty six)only incurred by WODC during the financial year 2023-24 (01.04.2023 to 20.08.2023) both in Administrative (**Rs.1,55,82,199/-**) and Development head (**Rs.101,76,93,787/-**).

**3. Approval of the Plan and Programme from 01.04.2023 to 21.08.2023.**

The Plan and Programme of the Council were discussed and approved 1415 numbers of projects amounting to Rs.118.82 crore which have been administratively approved from 01.04.2023 to 21.08.2023 as detailed below.
