NOTIFICATION

Sub: Declaration of Deputy Director, DPMUs in the Districts of Angul, Baragarh, Bolangir, Boudh, Deogarh, Jharsuguda, Kalahandi, Nuapada, Sambalpur, Subarnapur and Sundargarh as Officer in-Charge of WODC District office in the respective Districts.

The State Government after careful consideration have decided to declare the Deputy Director, District Planning & Monitoring Units in the DPMUs of Angul, Baragarh, Bolangir, Boudh, Deogarh, Jharsuguda, Kalahandi, Nuapada, Sambalpur, Subarnapur and Sundargarh as Officer in-Charge of WODC District office in the respective Districts.

2. The following arrangements will be made for the purpose:-

- i) Separate space will be provided in the premises of Deputy Director, DPMU for the Office of WODC with appropriate signages for information of the public.
- ii) WODC will determine the number of additional support staff for functioning of their District office and meet the staff cost and also provide contingencies to run the office.
- iii) The District Office will function under the administrative control of the Collector and report to WODC Headquarters. The District office will report to the Collector regarding day to day affairs and progress of WODC programmes.
- iv) The District Office will be entrusted with the following functionalities:
 - a) Submission of suitable proposal according to laid down procedures for scrutiny at headquarters.
 - b) Timely release of funds to the executing agencies for execution of the projects;
 - c) Review, Supervise, coordinate and monitoring of different developmental projects;
 - d) Submission MPR, UCs, reply of assembly questions etc. to the Council and
 - e) Convening of DLMC meeting in every month and submission of minutes.

This will come into effect immediately.
